Communication about any updates will be provided through GovDelivery and be posted to the division's website.

Insurers are also encouraged to allow consumers to attest to being affected by the fires and in good faith try to provide relief.

In using the table of ZIP codes, insurers are encouraged to consider any alternative workplaces for employees or secondary business locations that may be outside of the principal place of business location and were affected by an evacuation order.

This bulletin takes effect immediately.
